By entering, you represent that you have read the Official Rules located on the Contest Site, and that you agree to be bound by all of them, as applicable. Your email address will not only be a means of communication for the presumptive winner, you are signing up to receive future promotional emails from Martignetti Companies of NNE. We will not sell, distribute or share email addresses.

3. Prize: Prize package x 5 packages:

- 2 tickets to a Red Sox Home Game at Fenway Park. Game tickets non-transferable. Ticket dates offered are at the sole discretion of sweepstakes sponsor and cannot be exchanged. Approximate value \$150 each.
- 2 Red Sox World Series Jerseys. Jerseys are pre-purchased, are size large and cannot be exchanged. Approximate value \$135 each.
- A signed MLB ball from a member of the 2018 World Series Team. Value – “priceless”

Each winner must be 21 years of age or older at the time of entry.
